NEW CONSTRUCTION COMMITTEE RESOLUTION

BELLA VITA HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Amended and Restated Declaration (the "**Declaration**") is filed of record under: Clerk's File No. 2007-098476, Film Code No. 419-11-2468 et seq., in the Official Public Records of Real Property of Montgomery County Texas; and

WHEREAS, pursuant to the authority vested in the Bella Vita Homeowners Association, Inc. (the "Association") under the Declaration and the Association's Bylaws (the "Governing Documents"), and pursuant to the express authority of Article II Section 2, of the Declaration, the Declarant, and the Board of Directors (the "Board") is empowered with administering the New Construction Committee and Modifications Committee; and

WHEREAS, it is the Board's desire to clarify the procedural requirements and authority of the New Construction Committee in light of the transition from Developer control;

WHEREAS, all terms used herein shall be given their definition as provided for in the Association's Governing Documents; and

WHEREAS, pursuant to Article II Section 2 of the Declaration, the Board may perform the functions of the New Construction Committee, once the Declarant has sold and conveyed all of its Lots within the Properties; and

WHEREAS, the Declarant has sold and conveyed all of its Lots within the Properties;

NOW, THEREFORE, for the purpose of adopting this New Construction Committee Resolution for the clarification and enforcement of the New Construction Committee procedures; it is hereby

RESOLVED by the Association's Board that the following New Construction Committee Resolution be adopted.

NEW CONSTRUCTION COMMITTEE RESOLUTION

- 1. New Construction Committee. In its discretion, the Board of Directors will perform the functions of the New Construction Committee or appoint and remove members of such Committee. (See Article II, Section 2 of the Association's Declaration.)
- 2. **List of Approved Builders**. Acting as the New Construction Committee, the Board shall promulgate a list of approved Builders which will be of such a size (but a minimum of two) so as to offer individual Lot Owners a sufficient number of Builders from which to choose. The list may change from time to time in the discretion of the Board. (See Article II, Section 3 of the Association's Declaration.)
- 3. **Limitation of Liability.** The selection of an approved builder is entirely the Owner's decision. The New Construction Committee, the Association and the Board retain all limitations of liability as stated in the Association's Declaration. (See Article II, Section 3 and 7.)
