

CORINTHIAN POINT SWIMMING POOL General Rules and Regulations for Safety and Sanitation **EFFECTIVE JANUARY 1, 2012**

Official pool hours are 7:00AM to 10:00PM (seasonally); pool closed until 1PM on Mondays for maintenance; if Monday is a holiday, then the pool is closed on Tuesday until 1PM.

CORINTHIAN POINT POOL IS FOR THE USE AND ENJOYMENT OF ELIGIBLE MEMBERS AND THEIR GUESTS ONLY. NO eligible member or his or her guest is allowed access to pool without an eligible pool card.

Pool access cards are available at the CP office during regular business hours.

If an access card is lost, contact the office so the manager can delete the card from system, and issue a new card. There is a \$25.00 fee to replace lost pool access card; you may not have more than two valid pool access cards per membership at one time.

All members, children and members' guests must identify themselves and sign in upon entrance to pool area. Members' children and their guests must be fourteen years of age to access the pool. Member's children under 14 must be accompanied by a related, responsible person of at least 17 years of age to enter the pool area.

A Corinthian Point member must accompany all non-member guests. An adult member may bring up to 9 nonmember guests to the pool area at one time; member's children over 14 may only bring 2 guests (over 14 years old) at one time per pool access card.

- If members wish to bring more than 9 non-member guests to the pool area at one time it is considered a "pool party". The member must have board approval and a <u>certified lifeguard</u> attending the pool party (retained at their own expense), and pay a \$25.00 fee for up to 20 guests. If over 20 nonmember quests attend there is an additional fee of \$2.00 per person up to a maximum of 25 guests
- A maximum of 40 persons (members and non-members) may be in the pool at one time. Eligible Corinthian Point members have access to the pool during posted hours regardless if there is a pool party in progress.

ANYONE IN POOL AREA BEFORE OR AFTER POSTED HOURS SHALL BE CONSIDERED TRESPASSING

NO DIVING ALLOWED; RUNNING, DUNKING, PUSHING, UNRULY BEHAVIOR, LOUD MUSIC, PROFANITY OR LEWDNESS IS PROHIBITED IN THE POOL AND/OR POOL AREA

NO CLIMBING OF FENCE TO OBTAIN ACCESS TO POOL

DO NOT THROW HARD OBJECTS SUCH AS "TORPEDOES, ROCKETS OR REGULATION FOOTBALLS" AT OR AROUND ANYONE IN POOL OR POOL AREA

ANIMALS ARE NOT ALLOWED IN THE POOL OR THE POOL AREA PER STATE LAW

SWIM SUITS ONLY (no cutoffs). ALL INFANTS AND TODDLERS MUST WEAR SWIM DIAPERS

ABSOLUTELY NO ALCOHOLIC BEVERAGES MAY BE BROUGHT INTO THE POOL AREA UNLESS PURCHASED FROM THE CLUBHOUSE DURING BAR'S OPERATING HOURS (TABC RULE)

SMOKING IS PROHIBITED IN THE POOL AREA

GLASS CONTAINERS OR ANY OTHER POTENTIALLY DANGEROUS ITEMS ARE NOT ALLOWED IN POOL AREA

SWIMMERS MUST LEAVE POOL DURING POTENTIALLY DANGEROUS THUNDER AND/OR LIGHTING
