- Do not leave any garbage, bait, bait receptacles or fish remains at the fishing pier area
- Any unsafe or hazardous behavior by a member or their guest(s) will result in the suspension of the fishing pier area for 30 days
- No one is allowed to enter, tie-up to or dive from the breakwater adjoining the fishing pier area. This will be considered unsafe or hazardous behavior
