Park Rules for

Lake Conroe Forest Owners Association

Park rules apply to all properties owned by the Lake Conroe Forest Owners Association.

- Parks open to Active Members, Associate Members, and their guests. Trespassers will be prosecuted.
- All vehicles must have a current pass. Vehicles without a current pass are subject to towing.
- No motorized vehicles in parks or on dams except in cases of official Association business.
- Play and swim at your own risk. No lifeguard on duty. Association is not responsible for accidents.
- Fishing in all private lakes is "catch and release" only
- No cast nets, trot lines, or seines
- No glass containers
- No dogs without a leash
- No overnight camping
- No disorderly behavior or abusive language
- No fire arms
- All park guests are responsible for removing their own trash
- All laws must be obeyed
- Parks close at dark (does not apply to the community building)

This Policy is effective upon recordation in the Public Records of Montgomery County, Texas, and supersedes any policy regarding records production which may have previously been in effect. Except as affected by the TEXAS PROPERTY CODE and/or by this Policy, all other provisions contained in the Declarations or any other dedicatory instruments of the Association shall remain in full force and effect.

This is to certify that the foregoing Policy was adopted by the Board of Directors by unanimous consent, effective as of **November 14**, 2011, until such date as it may be modified, rescinded or revoked.
