## AMENDMENT

WHEREAS, certain Covenants, Conditions and Restrictions and other provisions applicable to Lakewood on Lake Conroe Subdivision, were recorded under File No. 8818992, Real Property Records of Montgomery County, Texas, and it is the desire to amend such instrument as hereinafter provided.

NOW, THEREFORE, the undersigned, being the Owners of two-thirds (2/3rds) or more of each type Lot as designated in Section 3.02, do hereby adopt, establish, promulgate and impress the following amendment to said Covenants, Conditions and Restrictions:

1) Section 4.06. Variances. is hereby amended and modified by eliminating the first sentence thereof and substituting the following sentence therefor so that the same shall hereinafter

The Committee may authorize variances from compliance with any of the provisions of this Declaration or minimum acceptable construction standards or regulations or requirements as promulgated from time to time by the Committee, when circumstances such as topography, natural obstructions, hardship, aesthetic or environmental considerations may require a variance or for other reasons or purposes when such variance is authorized by the Committee and thereafter approved in writing by the Owners entitled to cast not less than two-thirds of the votes of all Owners of each Lot type as designated in Section 3.02 of said Covenants, Conditions and Restrictions.

2) Section 6.02. Basis of Maintenance Charge, subsection (c) is hereby amended and modified by eliminating the first sentence thereof and substituting the following sentence therefor so that same shall hereinafter read:

The exact amount of the Maintenance Charge for each Lot type as determined in Section 3.02 will be determined, from time to time, by the Board of Trustees, and may vary between Lot types based upon factors determined by the Board of Trustees.

IN WITNESS THEREOF, Gary Richardson, Trustee, the Declarant in said Covenants, Conditions and Restrictions, has executed this Amendment as an instrument in accordance with ARTICLE XI, Section Amendment as an instrument in accordance with ARTICLE AI, Section 11.02 of said Covenants, Conditions and Restrictions and, the Owners representing two-thirds (2/3rds) of the Owners of each Lot type as designated in Section 3.02, have joined in the execution of this Amendment with said Declarant all as provided for in said Covenants, Conditions and Restrictions of Lakewood on Lake Conroe.
