#### **Roofing Materials Policy**



#### I. <u>Purpose</u>:

It is the intention of the Board of Trustees to allow the installation of appropriate roofing materials in Walden on Lake Conroe that maintains the aesthetics and architectural consistency of the community.

#### II. General:

The Property Code of the State of Texas allows for the installation of certain roofing materials that are wind and hail resistant, provide greater heating and cooling efficiencies that customary composite shingles or provide solar generation capabilities, subject to certain criteria. This policy is to comply with the law and appropriately regulate the selection and installation of these materials so that they do not detract from the appearance of Walden.

#### III. Policy:

- An Owner must obtain written approval from the Architectural Control Committee (ACC) prior to the repair, replacement or reconstruction of any roof.
- 2. All buildings with pitched roofs shall be roofed with composition shingles, slate, tile, or standing seam metal (excluding corrugated metal roofs) unless otherwise approved in writing by the ACC. Wood shingles are specifically prohibited for safety reasons.
- 3. All buildings with flat roofs must be approved in writing by the by the ACC, such approval shall include the material to be used to roof the building.
- 4. Composition shingles must weigh at least 280 pounds per square and have a stated warranty of at least 30 years.
- 5. Roof shingles must be "Weathered Wood" or similar color as approved by the Architectural Control Committee.
- 6. Roof overlays are not allowed. Prior to roofing, all existing materials must be removed down to clean decking. Any damaged or deteriorated decking must be replaced. Partial reroofing will not be allowed.
- 7. Ridge vent are encouraged, to improve ventilation, reduce attic temperature and reduce cooling costs, but are not required.
- 8. All roof protrusions, such as vents, roof jacks, as well as valleys, flashing and other roof items must be painted to match the shingles. Galvanized metal must be primed before painting.
- 9. Subject to the other requirements contained in this Policy and with advance written approval from the Architectural Control Committee, an owner may install shingles ("Alternative Shingles") which are designed primarily to:
  - a. be wind and hail resistant; or

- b. provide heating or cooling efficiencies greater than traditional composition shingles; or
- c. provide solar energy capture capabilities.
- 10. Once installed, any such Alternative Shingles must:
  - a. resemble the shingles used or authorized to be used on other structures within the Association; and
  - be more durable than and of equal or superior quality to the shingles used or authorized to be used on other structures within the Association; and
  - c. match the aesthetics of properties surrounding the owner's property.

This Policy is effective upon the later of recordation in the Public Records of Montgomery County and January 1, 2012, and supersedes any Policy for roofing materials which may have previously been in effect. Except as affected by State of Texas Property Code Section 202.011 and/or by this Policy, all other provisions contained in the Deed Restrictions or any other dedicatory instruments of the WCIA shall remain in full force and effect.
